Thank you for your interest in the forthcoming **Harrogate Autumn Flower Show**, to be held within the grounds of our exciting autumn venue, Newby Hall & Gardens, near Ripon, between 18-20 September 2026. This event will host traditional show favourites including plant nurseries, fantastic fruit and vegetables and live theatres, alongside spectacular feature installations and activities, all forming part of a unique event for garden-lovers.

Application process

A completed application is one received by Friday 22 May 2026 with full payment and Public Liability Insurance of £5,000,000, valid between 18-20 September and a show related risk assessment. All electronic applications will receive a confirmation receipt email. Following the deadline, successful applicants will be informed via email with a link to the exhibitor area of our website. This holds essential information relating to your stand, so please ensure that all details provided are correct.

Payment & refunds

Full payment is required at the time of application and in any case, no later than the application closing date of Friday 22 May 2026. Refunds for unsuccessful applications will be made by BACS once allocation has been completed in early July.

Venue and site information

Cost for space within the Food Market includes for a 3m x 3m space only within a covered structure. Most stands will adjoin, and all exhibitors must incorporate their own entrance through their allotted space. For those exhibitors wishing to place orders for temporary electricity supply, this is now arranged independently to the main application, with forms issued to successful applicants separately upon allocation in early July 2026.

Two exhibitor badges and one parking pass are provided per stand.

Products to be exhibited

Only products noted on the application form and subsequently approved can be sold during the show. Food sold within the Food Market is strictly for consumption off the premises. Sales of sandwiches, wraps or filled rolls etc, together with bottled waters and convenience drinks are strictly forbidden and alcohol sales are permitted for off-site consumption only. All staff selling alcohol must hold relevant licences and pay for a licence to sell alcohol at the show.

Please be aware that completion of this application does not represent a guarantee of space within the event. All applications and subsequent allocation of stands is at the discretion of Harrogate Flower Shows and we cannot guarantee the same stand as at any previous show.
